

REPORT AND RECOMMENDATION

The June 5, 1972 Grand Jury has heard evidence that has led it to return the indictment being submitted herewith. It has also heard evidence that it regards as having a material bearing on matters that are within the primary jurisdiction of the House of Representatives Committee on the Judiciary in its present investigation to determine whether sufficient grounds exist for the House of Representatives to exercise its constitutional power to impeach Richard M. Nixon, President of the United States. It is the belief of the Grand Jury that it should presently defer to the House of Representatives and allow the House to determine what action may be warranted at this time by this evidence.

It is the Grand Jury's strong and unanimous recommendation to the Court, therefore, that the evidence referred to above be transmitted forthwith to the House Judiciary Committee for such use as it considers appropriate, with the further recommendation that the Committee be advised of the Grand Jury's belief that this evidence should be received, considered, and utilized with due regard for avoiding any unnecessary interference with the ability of the Court to conduct fair trials of persons under criminal indictment.

The Grand Jury has compiled the evidence it recommends be transmitted to the House Judiciary Committee and it has instructed the Foreman to submit this evidence to the Court under seal for the Court's consideration.

II. MATERIAL BEARING ON THE PRESIDENT'S "INVESTIGATION."



IV. THE PRESIDENT'S PUBLIC STATEMENTS AND MATERIAL BEFORE THE GRAND JURY RELATED THERETO.

On May 22, 1973, the President said in a public statement that "[n]either did I know until the time of my own investigation [March 21, 1973], of any efforts to provide [the Watergate defendants] with funds." On August 15, 1973, the President said in a public statement that he was told on March 21, 1973, that money had been raised for payments to the defendants for attorney fees and family support and not "to procure silence from the recipients."

On August 15, 1973, the President publicly reaffirmed that statement, adding that he had consistently maintained since July 1972 a position "that under no circumstances could executive clemency be considered for those who participated in the Watergate break-in." On November 17, 1973, the President in a publicly televised question and answer session said that while clemency "was not recommended by any member of my staff . . . it was on occasion suggested as a result of news reports that clemency might become a factor," but the President said he "turned it down whenever it was suggested."
